**Job Summary:**

The Field Officer will support the effective implementation, monitoring, and coordination of HIV interventions seeking to reduce HIV incidence and improve sexual and reproductive health (SRH) outcomes among adolescent girls and young women (AGYW), Other Vulnerable Population and People Living with HIV in the target communities. The Officer will implement the project activities in a timely and professional manner, according to GF GC7 HIV Project objectives, goals and indicators and in line with donor requirements.

**Key Responsibilities:**

- Planning, Coordination, and implementation of HIV prevention activities, aligning with national strategies and Global Fund guidelines.
- Work with local structures to foster positive knowledge, attitudes & practices by community members on up take of HIV prevention and treatment services amongst all age cohorts.
- Foster strong working relationships with County Health Management Teams (CHMTs), community leaders, and implementing partners to ensure successful project delivery.
- Collaborate with C/SCHMTs to identify and engage Community Resource Persons (CORPs) to support peer education, defaulter tracing, adherence counselling, and treatment literacy and to reach priority populations including AYP, HRG, OVP, and PLHIV.
